- Submission of a project description which clearly states that the applicant is the principal investigator and that their academic progress would benefit from such funding support
- Evidence of strong research training, productivity, and a commitment to a career in fundamental (basic) and/or clinical research
- Upon application, the candidate must be responsible for the care of children
