

PSYCHIATRIST IN CHARGE POSITION AT MCLEAN HOSPITAL

McLean Hospital, America's top ranked freestanding psychiatric hospital, is inviting applications for a part-time (24 hour/week) **Psychiatrist in Charge** position at our Addiction Treatment Center at Naukeag, located in Petersham, MA.

McLean Naukeag is a residential treatment program for adults with co-occurring substance use and psychiatric disorders. The psychiatrist in charge oversees day-to-day clinical services of the program in conjunction with program leadership, and is responsible for the delivery of psychiatric services, including psychopharmacology services.

Successful candidate will provide clinical services to patients, document in the medical record, oversee completion of treatment plans, and complete discharge medications. As an integral member of the multidisciplinary clinical team, the individual in this role will participate in team rounds and other clinical meetings and help coordinate all treatment and discharge planning. The Psychiatrist in charge will meet with families for clinical discussions and communicate with referring sources, primary care physicians, and other community providers. be responsible for facilitating the integration of program services with other clinical programs, non-clinical departments and research in conjunction with program leadership.

Successful candidate will provide supervision of residents, medical students, fellows and others as appropriate.

Salary and recruitment package in accordance with Hospital policies, and a Harvard Medical School appointment at the academic rank of Lecturer, Instructor or Assistant Professor (full or part time) will be contingent on meeting the requirements for an HMS appointment and candidate qualifications including Massachusetts medical license, and being board certified/board eligible.

Qualifications:

Requires an MD degree with current license to practice in the Commonwealth of Massachusetts. Must have completed a residency in psychiatry. Board certification in psychiatry preferred. Completion of addiction psychiatry fellowship preferred.
