PEDIATRIC NEUROPSYCHOLOGY/PSYCHOLOGY POSITIONS

The DEAF AND HARD OF HEARING PROGRAM at BOSTON CHILDREN'S HOSPITAL is seeking a pediatric neuropsychologist and/or psychologist for 2 full time positions providing neuropsychological/psychological services to D/deaf and hard of hearing patients.

Within the Department of Otolaryngoloy and Communication Enhancement, the Deaf and Hard of Hearing Program is an interdisciplinary team of neuropsychologists, psychologists, speech language pathologists, audiologists, and a psychiatrist all with specialized training in the care of d/Deaf and hard of hearing children. Additional staff include a psychometrician, outreach coordinator, and research assistant.

The neuropsychologist/psychologist(s) will primarily provide assessment and short-term consultation/psychotherapeutic services for d/Deaf and Hard of Hearing children. The diverse patient population includes children with hearing aids, cochlear implants, bone anchored hearing systems (BAHS), and those who communicate in American Sign Language (ASL) or other visual languages. The neuropsychologist/psychologist is an active collaborator in the Cochlear Implant and BAHS Teams, as patients explore candidacy with audiology, speech-language pathology, and otolaryngology colleagues. Preference for candidates with American Sign Language skills and familiarity with Deaf culture. Pursuit of collaborative research activities will be strongly encouraged.

Boston Children's Hospital is a member postdoctoral training site of the Association of Postdoctoral Programs in Clinical Neuropsychology (APPCN) and Association of Psychology Postdoctoral and Internship Centers (APPIC), and the candidate(s) will be member(s) of the training faculty. Appointment at Harvard Medical School as Instructor, Assistant, or Associate Professor will be commensurate with experience. Ongoing teaching and/or supervision will be required.

An earned doctorate from an APA/CPA accredited doctoral program and completion of an accredited internship are required as well as a postdoctoral residency in clinical neuropsychology for the neuropsychology position or postdoctoral residency in pediatric psychology for the psychology position. Competitive candidates for this position will have comprehensive training in pediatric neuropsychology/psychology, preferably in a medical setting. Candidates must be licensed by the Massachusetts Board of Registration of Psychologists at the time of hiring.
